

Notice of Pending Application for Proposed Piers, docks and wharves

Timothy Walbert, 308 Courtland Ave, Park Ridge, IL 60068 has applied to the Department of Natural Resources for a permit to Piers, docks and wharves. The project is located in SE 1/4, NW 1/4, Section 11 Township 01N, Range 17E located in Town of Linn, Walworth County.

The proposed project includes adding an addition that consists of a new slip 14' x 46'. The current L that is 10' x 12' will be moved to the outside of the new slip. To create the new slip we will build a 6' x 30' 5 1/2" walkway with a 6' x 40' walkway that will create the new slip with canopy. There will be 3 new cribs added to the lakebed. We will be moving slip 5 that is for the L. All wood will be Doug fir, 6 x 6 posts and Jacks, 4 x 6 stringers, 2 x 8 decking. We will use fieldstone to fill in the cribs and hold them down.

The Department will review the proposal provided by the applicant and any information from public comments and the public informational hearing. The Department will determine whether the proposal complies with ss. 1.11, 30.12, 30.208, Wis. Stats., and ch. NR 150, Wis. Adm. Code.

The Department has made a tentative determination that it will issue the permit for the proposed activity.

If you are submitting general comments on the proposal, they must be emailed, verbalized, or postmarked within 30 days after the date this notice is published on the Department's website. If you are requesting a public informational hearing, the request must be emailed, verbalized, or postmarked within 20 days after the date this notice is published on the Department's website. A request for hearing must include the docket number or applicant name and specify the issues that the party desires to be addressed at the informational hearing.

If no hearing is requested, the Department may issue its decision without a hearing. If a public informational hearing is held, comments must be postmarked no later than 10 days following the date on which the hearing is completed.


The final decision may be appealed as indicated in the decision document.
